RESOLVED that Councillor Paul be elected as Chairman of the Youth Club Sub Committee.

YC24-37 Public Participation Session with respect to items on the agenda

YC24-38 Attendance Figures

Members received attendance figures for April 2023 – Dec 2023 as provided by YMCA. It was noted that the figures had decreased compared to previous years. Members were advised that:

- the pandemic had played a huge part of this, with schools and other youth clubs experiencing the same.
- whilst numbers appear low, the youth engagement was extremely high.
- 39 children are registered of which 30 are from Galleywood.
- approximately 15 are in attendance, there is a capacity of 35 at each session.
- school links have broken down and funding is restrictive for universal youth groups to apply.
- members are welcome to visit the children's sessions to get an understanding of how the children interact.

Actions:

- I. members to attend YMCA sessions
- II. clerk to provide YMCA with contact links for Secondary and Primary schools and Church
- III. clerk to provide YMCA details of all community events taking place by the council
- IV. Cllr Paul to provide YMCA with Keene Hall availability
- V. YMCA to provide a promotional article for the Spring Grapevine magazine by 31.01.2024
- VI. YMCA to complete office base research on opening times best practise

YC24-39 Budget

Members received proposal budget figures for 2024/2025:

Option 1:

 $3\,\%$ hours a week face to face delivery – 1-hour planning and preparation (Term time only) Two separate sessions - age 11-13 (4.30-6.30pm) and age 13-17 (6.30-8pm) 2 staff members

Costs £7,295

Option 2:

2 hours a week face to face delivery -1 hour planning and preparation (Term time only) Age groups combined together (age 11-17) 3 staff members (1 on less hours) Costs £6,420

Option 3:

2 hours a week face to face delivery -1 hour planning and preparation (Term time only) Age groups combined together (age 11-17) 2 staff members

Costs £5,040

RESOLVED that:

- No changes would be pursued to the current agreement pending the outcome of YMCA research.
 - (Two separate sessions age 11-13 (6pm 7.30pm) and age 13-17 (7.30pm 9.30pm) Costs £7,875)
- II. a recommendation would be made to full council for a YMCA representative to be appointed as an advisor onto the Youth Club Sub Committee.
