### Dog Bin

To consider if a dog bin will be relocated or a new bin purchased.

Members requested the clerk sought prices to relocate the current dog bin number 3, situated at Pavitt Meadow to nearer Footpath 76, Rignals lane. And also costs for a new additional bin.

CCC advised that they cannot monitor the bin usage, and only make notes if complaints are received of overflowing bins (of which there have been none).

CCC have advised that the lead time to relocate or install new will be between 1- 2 months. Costs below have been provided as follows:

### Relocate

Relocation fee of £65 +vat.

### **New Purchase**

Cost of Bin Supply £235 + vat.

Installation £65 + vat.

Yearly charge of £100 + vat for collection.

### Watchouse Shop area

To consider if a recommendation will be made to Full Council to formally take over the maintenance of Watchouse Shop garden area.

Members requested the clerk raise health and safety concerns with CHP prior to this consideration.

The surveyor from CHP has advised that their contractor finished on site on 22 May 2024 and all H&S risks have been removed.

CHP have agreed that their measure of quality centres around customer feedback.

Should they receive positive feedback from residents and members of the local community, then this helps to inform them that the service being provided is to a good standard, no feedback would suggest the service is ok and negative feedback would suggest the service is poor.

With this in mind, CHP would suggest that the Parish Council outline their plans for the area to enable them to agree timescales for review where we can assess any customer feedback received to establish quality.

CHP advised they would be happy to meet to talk through their thinking if this would help. The clerk has requested CHP attend this meeting to discuss further - awaiting response.
