**RESOLVED** that Galleywood Parish Council has concerns to the reserved matters (landscaping) relating to 22/00397/OUT (Outline application for the construction of 24 new dwellings with associated parking and private amenity space. Access, appearance, layout and scale being sought. Landscaping a reserved matter.) and fully support the comments made by residents.



The concerns raised are due to the following factors:

DM26 – it is does not provide off street parking at a ratio of one space per bedroom for properties around the access road. The Council would like to propose that the planned planting at the entrance to the development be replaced with a pathway that is flush with the road on both sides of the entrance. This would allow occupants residing in numbers 64,66,68 and 70 to apply for planning permission for off street parking and construct a driveway or hard standing to the front of their properties in addition to those provisioned within the development.

The Parish Council would like to propose that pavements are widened to allow occupants residing in numbers 72 and 74 to apply for planning permission for off-street parking and construct a driveway allowing for off-street parking in spite of the restrictive space on their properties.




DM29 – it does not safeguard the living environment of the occupiers of any nearby residential property by ensuring that the development is not overbearing and does not result in unacceptable overlooking or overshadowing. The Council would like to propose that trees are planted to provide effective screening behind plots 8 and 9.

In addition, the Parish Council would like confirmation that:

- a. house numbers 64,66,68 and 70 are allotted the four parking spaces located nearest to their property boundary. (Green coloured spaces outlined below)
- house numbers 64,66,68 and 70 are provided with gated access from the rear of their property boundary to their allotted car parking space. (Red Circles below)
- c. lockable bollards are installed in the parking spaces allotted to house numbers 64,66,68 and 70 or other protective measures allowing the spaces to be reserved to the respective allocated property and providing adjacent access to the rear of their properties.

- d. lockable bollards are installed in the parking spaces allotted to house numbers 72 and 74 or other protective measures allowing the spaces to be reserved to the respective allocated property.
- e. access to Cottey House is removed from the development to reduce pedestrian and cycle traffic around the sheltered housing.

The City Council are engaging with the landowners

## Walkabout around Parish

Meeting not required - recirculated the 2023/2024 spreadsheet to Cllrs to update with their findings – see agenda item 24-611.

## • Watchouse Shop Maintenance

CHP advised the shop area is attended to around once per month with mulching being carried out over the winter months. They are not able to increase the level of service in this area as this would need to be funded. They do not receive any service charge income to maintain the shops and must prioritise paid for services. Any new shrub planting or other expense such as bark chippings would be dependent on other teams being able to provide a resource to cover this.

**RESOLVED** that community engagement would be sought to establish a working party to help maintain the planted areas at Watchouse shops.

**Action:** Clerk to publish posters on noticeboards, social media and horticultural clubs within the village, to gauge interest.

## Residents Signage

## PARKING ON VERGES AND SIDEWALKS

I am writing to complain to you about the parking of vehicles on verges that are mown regularly, and on pavements and footways around the streets in Galleywood.

I enclose a letter which I addressed to my MP Sir John Whittingdale about the subject which provides photographic evidence of recent instances of the problem.

I also attach photos of the problem in Beehive Lane, where at weekends users of Chelmer Park continue to park vehicles on the mown verges of the road.

No doubt you are aware of the Essex Act which, with the County's permission, you as Councillors of the Parish are able to prosecute those who park on mown verges illegally.

Would you please take action to avoid the damage that could be caused to the grass verges in Beehive Lane, by warning those who park there not to do so in future?

I am also appealing to the City Council Parks Department, who are responsible for maintaining the grass verge alongside Chelmer Park in Beehive Lane, to see if they are willing to prevent parking on the verge.

I would be grateful if you could consider this request and let me know what action you decide to take.

# PARKING OVER PAVEMENTS/FOOTWAYS/VERGES

I am sure you are familiar with the problem of vehicles parked across the footway or pavement in areas where there are no yellow lines etc.

I have reported a vehicle that has been outside my house, parked with two wheels on the footway (see Photograph A), to both Chelmsford City Council and Essex Police. Neither can nor have a mind to take any action against the owner.

This vehicle is not the only vehicle in my street that is similarly parked over the footway — see Photos B to G enclosed. All these photos were taken by me on the same day.

The last Government wrote to me about this sort of problem to the effect that they thought drivers ought to be more thoughtful when parking their vehicles. They depended on the good will of drivers who they thought would be more considerate of other road users and park responsibly!

May I ask you to raise the matter with the relevant Minister? Could he review the need to ensure footways are used only by pedestrians and other road users who are allowed to use footways?

I understand it is illegal to drive a vehicle over the kerb onto the footway/pavement of a road (highway), or to park on a grass verge in Essex that is cut regularly. So why is action not taken against drivers of vehicles parked over the footway?

I have contacted Essex Highways, Essex Police, Chelmsford City Council and the South Essex Parking Partnership who all say they will not take any action in the cases I have raised with them.

It seems that pedestrians don't count!

The following photos were taken a few days ago in another street in Chelmsford and show a vehicle completely blocking the footway — parked facing a property over its dropped-down kerb, the footway, and drive into that property.

This last case shows that pedestrians would have had to use the carriageway to get round the three vehicles. This is clearly dangerous — especially as there are many schoolchildren in this area of Chelmsford.

Dear John,

Thank you for your letter of 1 November 2024, enclosing correspondence from your constituent, Mr Malcolm Lees of about problem of vehicles parked across footways or pavements in areas where there are no yellow lines. I am replying as the Minister responsible for this issue.

I fully understand concerns in relation to inconsiderate parking. The responsibility for traffic management generally rests with the appropriate local authority, including the provision or restriction of on-street parking, as they are best placed to consider how to balance the needs of residents, emergency services, local business and those who work in and visit the area. The Department has no remit to intervene in the day to day running of local roads.

With regards the issue of parking on the pavements, in 2020, the Department undertook a public consultation on options for changing the way pavement parking is managed outside London. The options include giving local authorities powers to civilly enforce the current criminal offence of unnecessary obstruction of the pavement; introducing a London-style pavement parking prohibition across England; and improving the Traffic Regulation Order (TRO) process by which local authorities may implement local pavement parking restrictions.

The Department's plan is to publish a formal response to the consultation, summarising the views received and announcing the Government's next steps for pavement parking policy, as soon as possible.

I am grateful that your Constituent, Mr Lees, has taken the time to write in on this all-important parking issue.

- 1. The Essex Act 1987 confers powers on Parish Councils, with the approval of Essex County Council, to deal with illegal parking on footways and verges alongside public roads.
- 2. Part III of this Act relates to Highways and Streets: Section 6 refers to verges of publicly maintainable roads:-

Grass verges, 6.—

- (1) This section applies to any of the following land in a district which, being in, adjoining or accessible from a highway, is mown or otherwise maintained in an ornamental condition:—
- (a) a grass verge, garden, lawn or green managed by a local authority; or
- (b) land laid out as a public garden or used for the purpose of public recreation which is vested in a person other than a local authority.
- 3. Parish Councils are 'local authorities' under clause (11) of the Essex Act 1987 and as such may make it illegal to park on a verge as defined above alongside a highway:-
  - (2) (a) A local authority may by notice prohibit, either entirely or at such times or on such days as may be specified in the notice, the doing of any of the following things on land to which this section applies:—
  - (i) driving, riding or leaving vehicles on the land;
  - (ii) allowing horses or cattle to enter the land;
  - (iii) using any equipment provided on the land.
- 4. A Parish Council may not exercise this power unless it has been given approval by the County Council:-
  - (b) A parish council shall not exercise the powers of this section in relation to any land forming part of a highway without the consent in writing of the county council.
- 5. The exceptions to this are:-
  - (4) Notice of a prohibition under subsection (2) (a) (i) or (iii) above shall not prohibit the driving or leaving of vehicles or the use of equipment on land—
  - (a) by any person engaged in building operations; or
  - (b) by statutory undertakers, the British Railways Board or the British Waterways Board where reasonably necessary in the exercise of their statutory functions; or
  - (c) by telecommunications operators where reasonably necessary for the purposes of their undertaking; but the exemption given by paragraph (a) above is conditional upon steps being taken to the satisfaction of the local authority to minimise damage to the land and to protect persons on the land.
- 6. Parish Councils would have to put up notices on the verge:-
  - (5) (a) For the purposes of this section notice shall be given by displaying it in a conspicuous position on or near the land to which it relates.

7. The signs have to comply with 'traffic signs' as defined in the Road Traffic Regulation Act 1984 and conform to regulations given under 5.05 (1) of that Act:-

(b) Where the notice is notice of a prohibition under subsection (2) (a) (i) above and relates to a grass verge forming part of or adjoining a highway used by motor vehicles (as defined in section 136 of the Act of 1984) it shall be a traffic sign, and the erection and display of the notice by the local authority shall be subject to, and in conformity with, general directions given under section 65 (1) of the Act of 1984 whether or not they are also the highway authority

8. The Parish Council may prosecute anyone who contravenes the notice:

(6) A person who, without reasonable excuse, contravenes a notice displayed under this section shall be guilty of an offence and liable on summary conviction to a fine not exceeding level 2 on the standard scale.

9. Any vehicle parked illegally on the verge may be removed:

7) (a) If a vehicle is left on any land in contravention of a prohibition under subsection (2) (a) (i) above, the local authority may cause the vehicle to be removed.

## 1. Scope

To set out the legal position in relation to parking on roadside verges, and possible remedial actions that may be considered.



## 2. Background

Parking particularly on grass verges can create significant problems for residents, highway users and Essex County Council as Highway Authority. Many complaints are received regarding damage and the condition of verges used regularly for parking.

The majority of roadside grass verges adjacent to the carriageway form part of the public highway and therefore come under the responsibility of the Highway Authority. It should be noted however, that in the case of roads where there was or is District Council housing stock, it is often the case that the large green areas are the responsibility of the District Council's Housing Department, and in some instances large green areas may also be common land or village green.

As the Highway Authority, it is Essex County Council's responsibility to maintain safe and unobstructed verges, particularly at junctions to ensure clear visibility for road users. However, it is not an offence to park on footway or verges, unless the location results in an obstruction. It may be a contravention of a Traffic Regulation Order (TRO) if there is one in place, or if there is a byelaw in force prohibiting it. In these instances, the matter would be referred to the local police or to the appropriate parking partnership, depending upon the contravention.

It is an offence for **Heavy Commercial Vehicles (HCVs)** to park on all footways or verges, irrespective of waiting restriction, as per Section 19 of the Road Traffic Act 1988. An HCV means any goods vehicle that has an operating weight exceeding 7.5 tonnes. In this instance enforcement can be undertaken by the Parking Partnerships.

- 19 Prohibition of parking of HCVs on verges, central reservations and footways.

  (1)Subject to subsection (2) below, a person who parks a heavy commercial vehicle (as defined in section 20 of this Act) wholly or partly—
  - (a) on the verge of a road, or
  - (b) on any land situated between two carriageways and which is not a footway, or
  - (c) on a footway, is guilty of an offence.
  - (2)A person shall not be convicted of an offence under this section in respect of a vehicle if he proves to the satisfaction of the court—
    - (a) that it was parked in accordance with permission given by a constable in uniform, or
    - (b)that it was parked in contravention of this section for the purpose of saving life or extinguishing fire or meeting any other like emergency, or
    - (c) that it was parked in contravention of this section but the conditions specified in subsection (3) below were satisfied.
  - (3) The conditions mentioned in subsection (2) (c) above are—
    - (a) that the vehicle was parked on the verge of a road or on a footway for the purpose of loading or unloading, and
    - (b) that the loading or unloading of the vehicle could not have been satisfactorily performed if it had not been parked on the footway or verge, and
    - (c) that the vehicle was not left unattended at any time while it was so parked.

## 3. Practice

If the land is highway the introduction of a Traffic Regulation Order may be considered to prevent parking on the verge.

## **Statutory Provisions**

There are several statutory provisions that may be appropriate to instigate in order to deal with persistent issues of roadside verge parking.

## **Traffic Regulation Orders (TROs)**

Any restrictions shown by the kerbside (i.e. yellow lines and signs) apply to the whole width of the public highway, up to the boundary of the adjacent properties including verges, unless otherwise stated in the TRO. Enforcement in Essex is undertaken by the two parking partnerships the South Essex Parking Partnership (SEPP) and the North Essex Parking Partnership (NEPP) under the Traffic Management Act 2004 within their parking and network management policies.

If parking on the verge is deemed acceptable or appropriate, but needs to be restricted on the carriageway, a TRO can be drafted to exclude the verge so that the restrictions affect only the carriageway. However, each case is considered on its merits and will be progressed by the appropriate Parking Partnership. Traffic Regulations Orders are introduced following a statutory process and must be accompanied by the appropriate signs or lines in order to give effect to the order, and enforcement is undertaken by the Parking Partnerships. If a traffic regulation order is deemed to be the appropriate course of action discussion should be held with the appropriate Parking Partnership in order to determine the time scale and extent of the problem.

#### **Byelaws**

The Essex Act 1987 section 6 creates a specific offence of parking on mown or ornamental grass verge and has been utilised for protecting large swathes of mown grass verge where parking was becoming an issue, such as The Greensward, Frinton. Extract from the Essex Act Appendix 1



However this Act is somewhat ambiguous in that the wording of the section states that it is an offence to park on an "ornamental" or mown verge. In other words the verge must be maintained to a higher standard than merely mown. ECC does not maintain verges to such a standard and for someone else to do this task they must have requested and received a license/consent from ECC. The Parking Partnership have begun to utilise the Essex Act and are having success with the sites so far treated under its provisions. This ability to use the Essex Act has been decriminalised and has its own code so may be used by both SEPP and NEPP. Requests for this form of enforcement to be undertaken should be made through SEPP or NEPP.

## **Obstruction Offence (Police) Statutory Provisions**

A particular incident of verge parking may be considered dangerous, obstructive or of causing damage and as such it may constitute a criminal offence under one or other of the following statutory provisions:

#### Section 28 Town Police Clauses Act 1847;

Wilfully causing an obstruction to any public footpath or public thoroughfare. Regulation 103 Road Vehicles (Construction and Use) Regulations 1986; Vehicles causing unnecessary obstruction of the road (including verge).

#### Section 22 Road Traffic Act 1988;

Leaving vehicles in a dangerous position on the road (including verge).

#### Section 137 Highways Act 1980;

Wilful obstruction of the free passage along a highway.

## Section 72 Highways Act 1835

Driving on any footpath or causeway by the side of any road made or set apart for the use or accommodation of foot passengers.

## Section 131(1)(c) Highways Act 1980;

Deposits anything whatsoever on a highway so it would damage the highway

Allegations concerning any of the above possible offences would be a matter for the police to investigate and enforce. However, in the current financial climate consideration must be given to the prioritisation of scarce resources and these matters may not be a priority for Essex Police.

## Possible options for consideration

Remedial action to either prevent or enable parking on verges needs careful consideration. Any action taken may result in unwanted parking further afield and demand for parking spaces is unlikely to be met in the majority of residential areas.

## **Bollards/posts**

Bollards/posts and verge marker posts are only effective when their need is respected. Widespread installation, plus maintenance needs would have significant resource implications for the Council and is not sustainable. Consideration also needs to be given to the diverting of the parking problem to other areas, as can often happen when implementing restrictions such as bollards or TRO's, there is often little that can be done about this, although care must be taken to ensure that any measures are equitable. Under the Highways Act section 96 The District/ Borough, City or Parish council may apply for a license from the Highway Authority to maintain the verge as part of which they could install bollards to protect the maintained verge. The Highway Authority can install bollard to protect under its own powers. However this increases the asset and puts an increasing burden on the maintenance liability. It also often creates a problem for grass cutting increasing the time required and often requiring the use of additional cutting equipment. Any request through the Local Highway Panels (LHP) should take account of the future maintenance liability which must rest with the LHP.

## **Converting Grass Verges to a Hard Surface**

It is possible to convert a grass verge to a hard standing surface such as grasscrete, block paving, concrete or bitmac. However, the cost of this is high and totally transforms residential areas encouraging parking, in reality it rarely provides the amount of parking required to meet demand. Request should be made through the LHP who would be responsible for future maintenance cost.

Objects placed upon verges by residents to prevent use/parking/overrunning It is an offence to place unlawful items on the public highway. If seen or reported the Highway Authority have the right to request that the items are removed. Failing this, the authority may remove the items. (A separate Policy document is currently been prepared to cover this in far more detail)

## 4. Procedure

All requests for action to be taken to prevent cars parking on grass verges should be made through the Local Highway Panel (LHP), unless for action under the Essex Act when initial discussion should be held with the appropriate parking partnership. The scale of the problem will be investigated and options for possible treatment put forward, following confirmation that the verge is highway. Any implementation of a statutory restriction will require the installation of the appropriate licence or order and the installation of the correct signs/lines.

The table below details the possible signing options for protecting verges.

## 7. InfoBase Text - Internal

There is no prescriptive right to park on the highway. The Highway is for the passing and re-passing of traffic (vehicular and non-vehicular). The authority to introduce parking restrictions in Essex has been delegated to a partnership between Essex County Council and twelve district/borough councils and is run in two areas; the North Partnership is led by Colchester Council and the South Partnership is led by Chelmsford Council.

Each Partnership is responsible for its area's on-street Civil Enforcement Officers ("traffic wardens"); the and enforcement process together with challenges to, and payments of, parking penalties ("parking fines") plus administration of the parking restrictions ("yellow lines") and the management and maintenance of the scheme.

Requests to deal with the parking of vehicles on highway verge can be dealt with in accordance with this HPN.

## Appendix 1

#### THE ESSEX ACT 1987

Grass verges, 6.—(1) This section applies to any of the following land in a district which, being in, adjoining or accessible from a highway, is mown or otherwise maintained in an ornamental condition:—

- (b) land laid out as a public garden or used for the purpose of public recreation which is vested in a person other than a local authority

- (2) (a) A local authority may by notice prohibit, either PART III entirely or at such times or on such days as may be specified in the notice, the doing of any of the following things on land to which this section applies:—
- (i) driving, riding or leaving vehicles on the land;

- (iii) using any equipment provided on the land.
- (b) A parish council shall not exercise the powers of this section in relation to any land forming part of a highway

without the consent in writing of the county council.
